RESOLUTION FOR AUTHORIZING SUMMARY PUBLICATION OF THE FOLLOWING AMENDMENTS TO ORDINDANCE NO 101 A SCHEDULE OF FEES AND CHARGES FOR VARIOUS SERVICES, LICENSES AND PERMITS FOR THE CITY OF AKELEY, MINNESOTA

WHEREAS, the City Council of the City of Akeley has adopted Ordinance No. 101, Schedule of Fees and Charges for various services, licenses for the city of Akeley, Minnesota (the “Ordinance”)

WHEREAS, Minnesota Statutes 412.191, subdivision 4 allows publication by title and summary in the case of lengthy ordinances or those containing charts or maps:

WHEREAS, the length of the Ordinance makes it impractical and costly to publish it in its entirety; and

WHEREAS, the City Council determines that the following summary would clearly inform the public of the intent and effect of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Akeley that the City Clerk Treasurer shall cause the following summary of the Ordinance, which is hereby approved, to be published in the City’s official newspaper in lieu of the entire Ordinance:

The City Council of the City of Akeley adopted the City of Akeley Schedule of fees and Charges for Various Services, Licenses and Permits Ordinance No. 101 section Sewer Connection Fees and Rates §12 and Water Connection Fees and Rates §12

12 The monthly charge for water pursuant to §54.01 shall increase annually January 2015 to January 2019 and will reflect on the February statements in accordance with the table below: All Commercial Water Services are subject to sales tax. ~~at the Current State of Minnesota Rate~~. All connections will be charged a Minnesota Department of Health Connection Fee at MDH set fee. The connection fee and sales tax will be adjusted accordingly with the City, County, State and MDH rates.
